Your Privacy. All information you provide, or that we collect, in connection with the Smartsheet ENGAGE – 2018 User Conference (the “Event”) will be saved, stored, processed, transmitted and/or deleted in accordance with the Smartsheet Privacy Policy, which you can view here: <https://www.smartsheet.com/privacy>.

Consent to Email. By registering for and attending the Event, you agree to be contacted by Smartsheet via phone or email with Event-related information or updates.

Valid Email Required. You will be asked to provide a valid company email address in order to register for the Event. If you do not provide such email address, your Event registration may not be processed.

Badges / Photo ID. When you check-in at the Event, we will verify your photo ID prior to assigning you your badge. Typical government-issued forms of ID will be accepted – e.g., drivers’ licenses or passports. Note that you will need a badge to enter the conference. Event badges may contain technologies that help us provide a better user experience, and track participation in various sessions.

Sharing Registration Information: You consent to allow Smartsheet to share your name, company, title and email address with certain Smartsheet ENGAGE sponsors only by swiping your badge at the applicable sponsors’ tables.

Cancellations and Transfers: Registration fees are transferable to another person within your company. If you have registered but are no longer able to attend, the following policies apply:

- Main conference: You can request a full refund through June 30, 2018. If you cancel between July 1, 2018, and September 15, 2018, you will be assessed a \$400 cancellation fee. If you cancel after September 15, 2018, you will not receive a refund.
- Pre-Conference Training: You can request a full refund through June 30, 2018. If you cancel between July 1, 2018, and September 15, 2018, you will be assessed a \$100 cancellation fee. If you cancel after September 15, 2018, you will not receive a refund.

Schedule Changes. Smartsheet reserves the right to modify event details as we see fit. We will make efforts to keep the registration site current for your convenience.

Photography / Video. We may take photographs and/or video during the Event, or have them taken for us, and collect recordings of your voice and likeness. By attending the Event you consent to Smartsheet’s use of these recordings, without payment of any kind, for any purpose, which may include use in our marketing materials and publications, and for our internal business purposes.
